I am also aware of the risks and dangers, including loss of control, collisions with other participants, trees, rocks, and other man made or natural obstacles, whether they are obvious or not obvious inherent with the activities that I and /or my family, including any minor children, are contracting for, and are fully capable of participating in those activities and willingly assume the risk of injury as my responsibility.

I also understand and agree that activities associated with, but not limited to, camping, rock climbing, ice climbing, mountain climbing, rappelling, mountain biking, backpacking, fishing, wilderness travel and living in the outdoors INVOLVE THE RISK of bodily injury, death or loss of personal property. I also state and acknowledge that immersion in water, hypothermia (rapid and medically serious loss of body temperature), exposure to temperature extremes, inclement weather and accidents or illness can occur in remote places without medical facilities, physician or surgeon.
